Course Description

Apartment buildings, office complexes, and retail centers do not manage themselves. Therefore, property owners hire managers to maintain and improve these and many other types of properties. Property owners seek out management services when they are personally unwilling or unable to assume the responsibilities themselves. The property manager, who also has the responsibility of leasing the managed property, acts as a liaison between the tenants and the property owner.

This course presents an overview of a property management company and the types of properties it might manage. Typically, the purpose of the property management company is to generate income for the clients and increase/preserve the value of the managed property. Therefore, the property manager makes sure that the property is adequately insured and maintained and that the tenants selected will pay their rent on time.

When dealing with residential tenants, property managers must follow the Florida Residential Landlord and Tenant Act and federal and state fair housing laws. Since the property manager acts as an agent of the property owner, all aspects of working with tenants—from leasing to eviction (if necessary)—must be done according to the law in order to protect the owner.
